Entry Day

Entries must be hand-delivered to the exhibition site at 603 F Street, Eureka between 11 am - 2 pm on Saturday, July 15, 2017.

Eligibility and Entry Fees

Entry is open to all residents of Humboldt County. Membership in Redwood Art Association, Eureka Photoshop Users Group or Redwood Camera Club is not required. Entry fees are \$15 for one entry \$35 for two entries and \$60 for three entries, with a maximum of three entries per person totaling \$60. Make checks payable to the RAA. Credit cards accepted.

Awards and Arts Alive! Reception

A Private Preview and Reception for entrants and guests will be held from 5 - 6 p.m. before Arts Alive!, on Saturday, August 5, 2017. "First Place" \$250, "Second Place" \$125, "Third Place" \$75, a \$100 Redwood Camera Club Founders' Award and five \$50 "Award of Excellence" awards will be presented at 5:30 p.m.

Pick Up Day

Exhibited work must remain on display for the entire show through Friday, August 18, 2017. Work may be picked up on **Friday, August 18, from 4 - 5 pm or Saturday August 19, noon to 3 pm.** Please present artist's receipt when claiming work. If you cannot come on that day, designate someone else to come with your receipt or a note from you to pick up your work. Artwork cannot be held beyond August 19, 2017.

Presentation Specifications

All work must be suitably prepared for exhibition. **Must be ready for hanging with strong hanging wire (or professionally installed picture cord) securely attached to a strong frame. No sawtooth hangers. No "U"clip Frames.** We recommend photographs be protected by glass or Plexiglas. No uniframe with glass or glass and clips. **NOTE: Overall framed dimensions can be no wider than 48". Weight limit of 35 lbs.** No diptychs, triptychs or other separate multi-paneled works can be accepted. Canvas on stretcher bars is acceptable.

Restrictions

Entries must be new original work or original collaborations not older than **5 years**, of the artist/artists and **not previously exhibited** in a Humboldt Photography Exhibition. No prior award winning images from any exhibition will be accepted. Exhibition organizers reserve the right to refuse work on the basis of content unsuitable for the exhibition. Entries must not violate

copyright laws.

Insurance/Liability

Work entered in the exhibit and while it is on the premises of the exhibit will be insured as provided for in the insurance policy issued to the Redwood Art Association in force at the time of the exhibit. The artist is required to declare the insurance value of the work. That value cannot exceed the sale price of the work. The insurance is limited to seventy percent (70%) of the declared value with a \$1,000 deductible per occurrence. Earthquake is excluded. If requested, proof of insurance value in the form of licensed appraisal or documented sales history shall be provided. A value in excess of \$25,000 shall not be accepted. The RAA reserves the right to deny entry based upon its determination of excessive value for insurance purposes. Upon any loss occurrence with multiple claimants, the deductible required by the policy shall be spread ratably among the claimants.

The RAA, EPUG, and RCC will not assume responsibility for damages to works while in transit to or from the exhibit nor for any works left beyond the pickup date. The RAA is not liable for wear and tear that may occur by handling during entry, spotting, hanging and take down. Entering work into this exhibition shall imply agreement on the part of the artist to the conditions set forth here.

Sale of Works of Art

The Redwood Art Association will collect a commission of thirty percent (30%) on the sale of a work of art on exhibit. The association will assume responsibility for sales tax and processing the sale, notifying the artist of the sale and delivering the art to the buyer. The amount due the artist will be paid within thirty (30) days of the close of the exhibit or receipt of final payment if it is a layaway purchase.

Copyright Agreement

I understand that the copyright ownership of my entry remains with me. The RAA, EPUG and RCC retain the right to reproduce images of the art for their own archival record and/or to publicize and promote this exhibition and/or the Redwood Art Association, Eureka Photoshop Users Group and Redwood Camera Club.
