Rules Governing this Virtual Exhibition

## Online Entry

Entries may be submitted online at <https://www.redwoodart.us/exhibitions.htm>. In addition to your contact information, we require details describing your entries. You will then upload images of your entries and pay your application fee with a credit card or PayPal.

## Restrictions

All submitting artists must be Humboldt county residents.

Entries must be new or recent original work or original collaborations, of the artist/artists. Organizers reserve the right to refuse work on the basis of content unsuitable for the exhibition. Entries must not violate copyright laws.

## Entry by Mail

Entries will **not** be accepted by mail.

## Entry Submission Deadline

Entries must be submitted online and received by April 10, 2021.

## Entry Size Limit

Since this is an online exhibition, there are no size limits.

## Entry Submission Rules

There is a limit of 3 entries per person. Each entry must include a minimum of 2 images. The first image must be of the entire artwork and the second image showing an alternative view or detail. A third image of an additional view or detail is allowed, with a maximum of 3 images per entry.

## Image Rules

All images must be clear, in JPG format, and sized so that they are 1500 pixels in the largest dimension. A video demonstrating how to take images and size them will be available on the RAA website in February.

## Entry Fees

**For RAA Members:** \$15 for the first entry, and \$10 for each subsequent entry, up to the 3 entry maximum.

**For Students:** \$10 for the each entry, up to the 3 entry maximum.

**For Non-RAA Members:** \$20 for the first entry, and \$15 for each subsequent entry, up to the 3 entry maximum.

All entry fees must be paid at time of entry by credit card or PayPal.

## Judged Exhibition

As this is a judged exhibition, it is the policy of RAA is to accept all submitted work.

## Sale of Works of Art

The Redwood Art Association will collect a commission of thirty percent (30%) on the sale of a work of art on exhibit in the online gallery. The association will assume responsibility for sales tax and processing the sale, notifying the artist of the sale and help manage pick up of the art by the buyer. The amount due the artist will be paid within thirty (30) days of the close of the exhibit.

If the artist is approached independently, outside of the RAA, to sell a work of art on exhibit in the online gallery, the artist is still bound by the RAA agreement to pay the 30% commission. The commission requirement also applies to transactions that take place within 90 days of the closing of the exhibition.

The RAA Sales manager will act as a liaison between the artist and the buyer.

## Copyright Agreement

I understand that the copyright ownership of my entry remains with me. The RAA retains the right to reproduce images of the art for their own archival record and/or to publicize and promote this exhibition and/or the Redwood Art Association.

The Fiber 2021 exhibit will be available online for one month as the Current exhibit, then for two additional months as a Past Exhibit. During this three month time period your art will be displayed as available for purchase and may not be offered for sale elsewhere.
